# Report on the Financial Statements

We have audited the accompanying financial statements of Judo Federation of India, which comprises the Balance Sheet as at 31<sup>st</sup> March 2022, Income and Expenditure Account (herein after referred to as Financial Statements) for the year ended 31<sup>st</sup> March 2022, and a summary of significant accounting policies and other explanatory information.

# Management's Responsibility for the Income and Expenditure Statements
