

FINAL ELECTION REPORT

DATED: - 08-06-2026

1. The election of the Judo Federation of India was conducted on 8th June 2026 under my Chairmanship in accordance with the election schedule notified for the purpose.
2. The election proceedings commenced at 11:00 A.M. in the presence of all contesting candidates, the Government Observer, Mr. Bangararaju, and the IOA Observer, Mr. Sahdev Yadav.
3. Prior to commencement of polling, the Government-issued identity documents of all members whose names appeared in the Electoral Roll were duly checked and verified.
4. The Electoral Roll comprised a total of 64 members.
5. Out of the 64 members, two members, namely:
(i) Mr. Tagru Kasha (Arunachal Pradesh) bearing electoral No. (5)
(ii) Mr. Parth Jindal (Tamil Nadu) bearing electoral No. (49)
remained absent and did not participate in the polling process.
6. Accordingly, 62 members were present and eligible to cast their votes.
7. Pursuant to the directions of the Hon'ble High Court, Mr. B. Kailasam Yadav was permitted to cast his vote under a sealed cover. After casting his vote, the ballot was duly kept in a sealed cover and was not included in the counting process.
8. Polling commenced at 11:30 A.M. and concluded as per the prescribed schedule.
9. Excluding the sealed-cover vote of Mr. B. Kailasam Yadav, a total of 61 votes were polled for the election.
10. Upon scrutiny of the ballots, one vote was found invalid.
11. Accordingly, the total number of valid votes counted for declaration of results was 60.
12. The result of the candidates based on the valid votes counted is mentioned below:

13. In the Outstanding Sportspersons Category, a total of 61 votes were cast. Out of these, 12 votes were rejected, while 49 votes were found valid. Upon counting and verification of the valid votes, the results of the Outstanding Sportspersons Category were duly tabulated and recorded.
14. It is noted that Ms. L. Sushila Devi was required to submit a No Objection Certificate (N.O.C.) from her Government Department.
15. In place of the N.O.C., Ms. L. Sushila Devi has submitted an affidavit/undertaking stating that she shall furnish the requisite N.O.C.
16. The undertaking submitted by Ms. L. Sushila Devi is accepted, and she is granted a period of seven 7 days to submit the requisite N.O.C. from the concerned department.
17. In the event that Ms. L. Sushila Devi fails to submit the requisite N.O.C. within the stipulated period, her candidature in the Outstanding Sportsperson (Female) Category shall stand liable to be cancelled, and the candidate securing the next highest number of valid votes shall be declared elected in her place.
