Whereas, by the letter dated 4th February 2022, the President, Judo Federation of India (JFI), I have been appointed as Returning Officer, for conducting the elections for the Office Bearers and Executive Committee of the JFI, on 5th March 2022 at 12.30.p.m.. at Hotel HK Clarks Inn, District Shopping Complex, SU-14, B-Block, Ranjit Avenue, Amritsar, Punjab – 143001.

As per the requirement of Clause No. 8 &10 of the JFI Constitution, a Notice for the Annual General Body Meeting of the JFI, to be held on 5th March 2022 at Amritsar, Punjab, to elect Office Bearers and Executive Committee, JFI, has been issued by the Vice President, JFI, vide Letter No. JFI/AGM/2022/005, Dated 02/02/2022 (enclosing therewith the required provisions of the JFI Constitution, for election).

Now, being the Returning Officer, I have fixed the following schedule for the elections of the Office Bearers and Executive Committee of JFI:



2. The following important provisions are also given:

- (1) The nomination of a Candidate for election as Office Bearers or Member of Executive Committee shall be made in Form – 2
- (2) The nomination of a Candidate for election as Office Bearer or Member of Executive Committee shall be proposed by one of the representatives of State / Union Territory, whose name is included in the Electoral College list, in Form – 1, and also submitted by 1 (one) such representative as Seconder.
- (3) No person shall be eligible to nominate more than one Candidate for the same post, either as proposer or seconder; and, if he/she so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be invalid.
- (4) No person shall be permitted to withdraw his/her name as proposer / seconder, once the nomination paper submitted by him/her has been delivered to Returning officer.
- (5) The eligibility of Candidate will be as per Govt. Guidelines NSDC - 2011
