Whereas, by the letter dated 8th July 2013, the General Secretary, Judo Federation of India (JFI), I have been appointed as Returning Officer, for conducting the elections for the Office Bearers and Executive Committee of the JFI, on 4th August 2013, at Imphal, Manipur.

As per the requirement of Clause No. 8 &10 of the JFI Constitution, a Notice for the Annual General Body Meeting of the JFI, to be held on 4th August 2013 at Imphal, Manipur, to elect Office Bearers and Executive Committee, JFI, has been issued by the General Secretary, JFI, vide Letter No. JFI/AGM/2013/107, Dated 17/2013 (enclosing therewith the required provisions of the JFI Constitution, for election).

Now, being the Returning Officer, I have fixed the following schedule for the elections of the OfficeBearers and Executive Committee of JFI:

Preparation of Final List of contesting candidates	26 th July 2013	By 4.30.p.m.
Elections	4 th August 2013	During the AGM at Imphaland duration will be 2 hours.

2. The following important provisions are also given:

- (1) The nomination of a Candidate for election as Office Bearers or Member of Executive Committee shall be made in Form - 2
- (2) The nomination of a Candidate for election as Office Bearers or Member of Executive Committee shall be proposed by one of the representatives of State / Union Territory / Department / Associate members, whose name is included in the Electoral College list in Form - 1, and also subscribed by 1 (one) such representatives as Secondor.
- (3) No person shall be eligible to nominate more than one Candidate for the same post, either as proposer or secondor; and, if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- (4) No person shall be permitted to withdraw his/her name as proposer / secondor, once the nomination paper subscribed by him/her has been delivered to Returning officer.
