- 2. The following important provisions are also given:
  - (1) The nomination of a Candidate for election as Office Bearers or Member of Executive Committee shall be made in Form 2
  - The nomination of a Candidate for election as Office Bearers or Member of Executive Committee shall be proposed by one of the representatives of State / Union Territory / Department / Associate members, whose name is included in the Electoral College list in Form 1, and also subscribed by 1 (one) such representatives as Seconder.
  - No person shall be eligible to nominate more than one Candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
  - (4) No person shall be permitted to withdraw his/her name as proposer / seconder, once the nomination paper subscribed by him/her has been delivered to Returning officer.
  - (5) The eligibility of Candidate will be as per Govt. Guidelines / Sports Code.
