  - (3) No person shall be eligible to nominate more than one Candidate for the same post, either as proposer or seconder; and, if he/she so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be invalid.
  - (4) No person shall be permitted to withdraw his/her name as proposer / seconder, once the nomination paper submitted by him/her has been delivered to Returning officer.
  - (5) The eligibility of Candidate will be as per Govt. Guidelines NSDC 2011
